5. Electronic bids must be submitted to **Ramaroshan Rural Municipality**, Nepal through PPMO website www.bolpatra.gov.np/egp on or 27 february, 2023 12:00.
6. The bids will be opened in the presence of Bidders representatives who choose to attend at 27 February 14:00 hours at the **Ramaroshan Rural Municipality**. Bids must be valid for a period of 90 of days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of **NRs 1,70,000** which shall be valid for 30 days beyond the validity period of the bid.
7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission. The Employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
